Dear Hon. Marco Pannella,

Firstly, I wish, on behalf of our members and supporters and on my own behalf, to express our deepest gratitude to you and your respective TRP for your continued support and taking actions to let the world know about the human and religious rights violations committing by the Vietnamese authorities upon the indigenous Khmer Kampuchea Krom in Kampuchea Krom (Mekong Delta or South Vietnam) and the strong support the Khmer Kampuchea Krom Community and other Khmer Krom civic organizations receive from you and TRP.

I would like to bring to your attention of the recent development in the Kingdom of Cambodia. On June 30, 2007 Chief Abbot Tim Sakhorn, Buddhist monk of Wat Phnom Den North, Phsa village, Phnom Den commune, Kirivong district, Takeo province, was invited to attend a meeting held at the provincial Buddhist office. His Venerable Tim Sakhorn was forcibly defrocked (disrobed) or leave monkhood against his will and the Buddhist teaching. On the same day, he was abducted by a group of people and transported swiftly to Vietnam (according to the Cambodian Ministry of Interior).

The Cambodian Supreme Buddhist leaders, the highest religious institution in the country, Vens. Tep Vong and Non Nget issued a directive to defrock Ven. Tim Sakhorn for his alleged action to dilute (destroy) the friendship of Cambodia-Vietnam.

The directive is unconstitutional and against the Buddhist rule. The procedure to disrobe a monk is also illegal. It is a blatant human right violation and contrary to the UN Charter and Universal Declaration of Human Rights.

According to the Cambodian Constitution, Khmers of Kampuchea Krom (Buddhist monks and lay people), who arrived in Cambodia are automatically Khmer citizens.

The safety, security and health of His Venerable Tim Sakhorn remain unknown.

My colleagues, members, and supporters in the United States, Canada, worldwide, especially in Cambodia are very concerned.

We wish to urgently request, Your Honorable, to intervene according to laws of Kingdom of Cambodia, Vietnam, and the United Nations to secure the release of His Ven. Tim Sakhorn.

We wish to see the safe return of His Venerable Tim Sakhorn from Vietnam to Cambodia, the involved authorities re-ordain the monk, and restore his status as Chief Abbot of his temple.

We wish to see the Cambodian Ministry of Cult and Religious Affairs' Minister Khun Haing and the highest Buddhist institution rescind their dated June 8, 2007 6-point directive prohibiting Buddhist monks from participating in strike, rally, demonstration and Dharma Walk or March for Peace.

We wish to see the Cambodian national Buddhist institution ceases all threats and intimidations of further illegal defrocking and kidnapping upon the Buddhist monks against their will and Buddhist practice, especially the 11 Khmer Kampuchea Krom Buddhist leaders and non-governmental organizations' leaders and human right activists.

I wish to thank you, Honorable, for your assistance in this matter.
